



Authorised Service Persons for Aerobic Treatment Units

Due to their design, Aerobic Treatment Units have service requirements under the Health (Treatment of Sewage and Disposal of Effluent and Liquid Waste) Regulations 1974 and the Code of Practice for the Design, Manufacture, Installation and Operation of Aerobic Treatment Units (ATUs) Serving Single Dwellings.

Service personnel are required to be approved as 'Authorised Persons' under the Regulations, or be their staff/subcontractors.
