- 4 Consider any submission received in connection with proposed local law [a period of at least 6 weeks must have elapsed since date of publication in the newspaper]

[Note: (i) Section 3.12(3)(a)(iii) & (4) *Local Government Act 1995*;
 (ii) If as a result of submissions or other factors local law is changed so as to be significantly different to what was first proposed, then procedure for making the local law must be recommenced - Section 3.13 *Local Government Act 1995*.
- 5 Council considers and makes proposed local law
