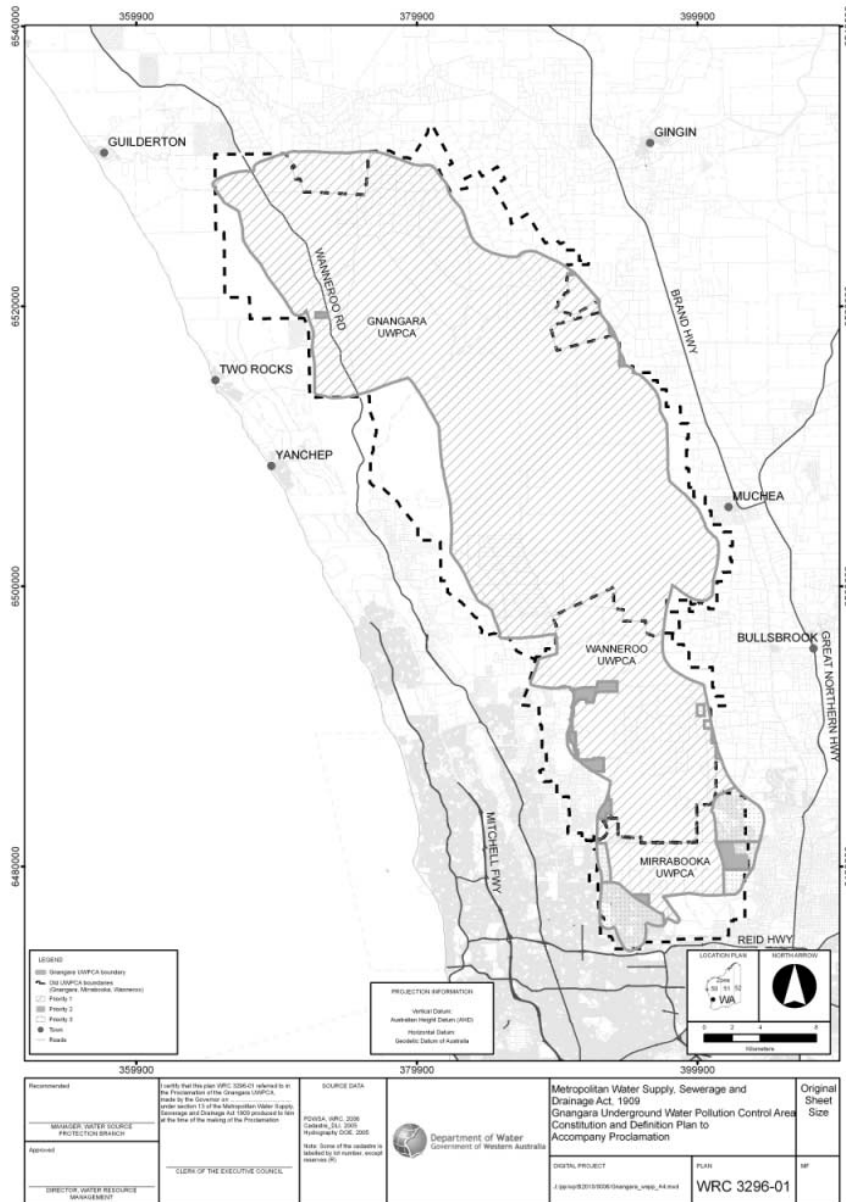
1. abolish the Gnangara Underground Water Pollution Control Area constituted and declared by a proclamation published in *Gazette* 3 August 1990 at page 3666-7; and
2. abolish the Mirrabooka Underground Water Pollution Control Area constituted and declared by a proclamation published in *Gazette* 18 December 1981 at page 5165-6; and
3. abolish the Wanneroo Underground Water Pollution Control Area constituted and declared by a proclamation published in *Gazette* 12 December 1975 at page 4483; and

which area is represented for information purposes in the plan in Schedule 1.

1. Citation

This instrument may be cited as the *Electricity Corporations (Western Power Corporation (Gas Supply) Direction) Revocation Direction 2007*.

2. Commencement

This instrument comes into operation on 1 July 2007.

3. Revocation

The *Western Power Corporation (Gas Supply) Direction 2000* as amended from time to time is hereby revoked and replaced with the *Electricity Corporations (Gas Supply) Direction 2007*.

1. CitationThis instrument may be cited as the *Electricity Corporations (Gas Supply) Direction 2007*.**2. Commencement**

This instrument comes into operation on 1 July 2007.

3. Definitions

In this instrument—

“**Corporation**” means the Electricity Retail Corporation.“**South West Interconnected System**” means the electrically connected electricity supply system into which electricity is supplied by one or more of the power stations at Kwinana, Muja, Collie and Pinjar.“**specified area**” means those parts of the State that were the subject of trading licences granted under Part 2A of the *Energy Coordination Act 1994* on 1 July 2000 to the Gas Corporation established by the *Gas Corporation Act 1994*.**4. Direction**

(1) The Corporation must not sell or supply gas to a customer whose consumption of gas is less than 0.18 terajoules per annum within, or for delivery or consumption within, the specified area.

(2) Nothing in subclause (1) is to be taken to prevent the Corporation continuing to perform its obligations or exercise its rights under an agreement existing at the date of commencement of this instrument, relating to the sale or supply of gas.

5. Limits on effect of clause 4Clause 4 ceases to have effect if the Minister, by notice published in the *Gazette*, declares that—

- (1) rules are in force under which any person may supply electricity to customers no matter how much or how little electricity the customer takes; and
- (2) the information technology and systems needed to facilitate the supply of electricity under those rules are established and operational for the South-West Interconnected System.

2. Reference on Water Corporation tariffs

- (1) Under the *Economic Regulation Authority Act 2003* section 32(1) the Treasurer has referred to the Economic Regulation Authority for annual inquiry the matter of the Water Corporation's tariffs.
- (2) The terms of reference are set out in Schedule 1.

3. Period of inquiry

The period of inquiry is as follows —

- (a) for 2007 — 22 February to 7 March;
- (b) for each subsequent year — 1 January to 15 February.

Schedule 1 — Terms of reference

[cl. 2(2)]

I, ERIC RIPPER, Treasurer, pursuant to section 32(1) of the *Economic Regulation Authority Act 2003* (the ERA Act), request that the Economic Regulation Authority (the Authority) undertake an annual inquiry and make recommendations on the most appropriate level of tariffs for the Water Corporation's (as established by the *Water Corporation Act 1995*) customers.

While a major review of tariffs is envisaged, perhaps once every three years, the annual reviews under these Terms of Reference would be more limited and may focus on particular issues of relevance at the time. The Authority is to investigate and report on the following matters:

1. Based on the Water Corporation's fees and charges submission to Government, the Authority is to provide advice on an annual basis, on the appropriate tariff levels for the Water Corporation's services (residential and non residential);
2. The impact on the Water Corporation's customers associated with the recommended tariff levels; and
3. The impact on the State Government's net financial position associated with the recommended tariff levels.

In developing its recommendations the Authority is to have regard to the Government's social, economic and environmental policy objectives and to the following policies:

- the pricing principles of the 1994 Council of Australian Governments water reform agreement and the National Water Initiative;
- the Western Australian State Government's Uniform Pricing Policy;
- the Western Australian State Government's Sustainability Policy;
- the Western Australian State Government's Community Service Obligations Policy; and
- the pricing mechanisms available to the Water Corporation through the *Water Agencies (Powers) Act 1984*.

The Authority will make available to the Treasurer a draft report before close of business on the third Friday in February each year and a final report as soon as practicable thereafter.

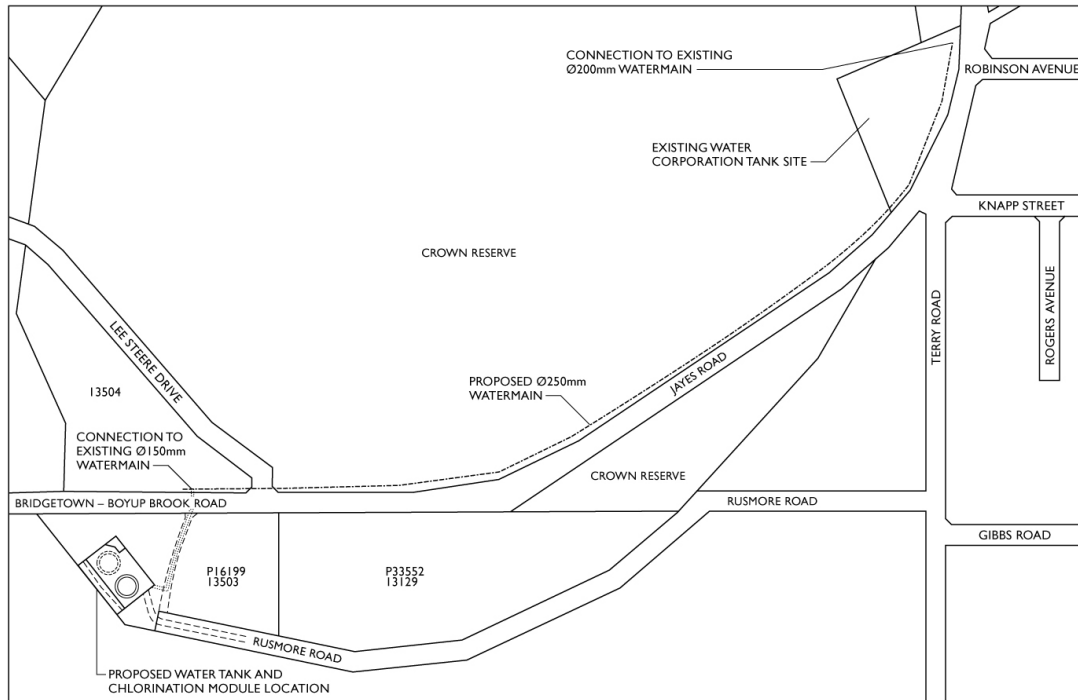
